1. Introductions and Apologies

Apologies were noted.

2. Minutes of the last meeting 23 June 2022

No comments were received, the minutes were accepted.

3. Recent Developments at EM3

Stephen Martin briefly went through recent developments including a number of new members to join the team. Sue Littlemore added that they have a very strong communications team which is important to maintain profile in the region.

Michael Queen added that one of the strengths is that they have a group of very strong universities and EM3 is helping them to get better in promoting themselves and enable businesses to engage.

4. Board Appointments

The two Surrey district JLB representatives to the main EM3 Board were agreed off line in September, Cllr Paul Follows, Waverley Borough Council and Cllr Julia McShane Guildford Borough Council.

A representative for Hampshire districts was still required and the nomination for Cllr Martin Tod was agreed.

5. Economy Update

Sue Littlemore shared the EM3 Economy, Labour Market and Skills Dashboard updated bimonthly. Sue indicated that there is high inflation, a tight labour market but evidence suggests unemployment remains low.



There was a sharp slowdown in business activity in October across the South-East because of customers reducing spending with activity is at its lowest level since 2008. Since the pandemic the EM3 area has lost nearly 3,000 businesses, most within the last 12 months, mainly small businesses of 1 to 10 employees. EM3 and Berkshire have each lost five major businesses, more than 250 employees.

David Neighbour wanted to make sure that we understand that we have some working solutions, unemployment low around the area, are we content that our education sector is well placed to fill the gaps.

Sue Littlemore responded that it is a real challenge. There is a limit to what our colleges and universities can do with the money that they have. A lot of work was done to accelerate the provision of skills and everybody agreed that those skills were needed for the future, but the colleges aren't able to get the businesses to invest.

Stephen Martin wanted to mention that the work that was being done was to facilitate where the investment should be with the different skills.

Cllr Tod asked if we had had any input from Public Health or the ICB, was it long covid driving it.

Michael Queen suggested that EM3 will approach Public Health and ICB to get the answer. Some people are opting out of commuting since the pandemic and others have decided to retire early.
